- When:** Monday: June 21st - JV Team Camp
Tuesday: June 22nd- Varsity Team Camp
- Where:** Centennial Public School - 1301 Centennial Avenue Utica, Nebraska 68456 (5 miles north of exit 366 off the interstate)
- Cost:** \$175 for 1 day. \$300 for both days. \$100 for each additional team you bring on the JV day (ex: 2 JV teams, 1 varsity team = \$400). Make check out to "Centennial Girls Basketball" - you can bring the day of the camp.
- Games:** 3 games for each team each day.
- Times:** Begins: 9:00. Games scheduled in 45 minute time slots. We can schedule your first games later if you're commuting from a distance. You will not play back-to-back unless requested. We want your team to be rested and also to have time to eat lunch.
- Officials:** 3 paid officials in each gym.
- Food:** Coaches Hospitality Room. Drinks in all gyms for coaches and officials. Spaghetti & Breadstick lunch will be provided for all!
- Gyms:** Two courts in our new (2015) gym. One court in our other competition gym onsite.
- Other:** Basketballs WILL be provided for warmups/games. Please bring matching-colored reversible jerseys for games.

Game Rules

1. Regular high school rules will be used
2. 2 minute warm-up and halftime
3. 16 minute halves with running clock
4. Clock will stop in the final minute of each half for FT & deadballs
5. Individual fouls won't be kept: Double bonus at 7 team fouls each half
6. **THE DOUBLE BONUS WILL BE IN EFFECT FOR BOTH TEAMS IN THE FINAL MINUTE OF EACH HALF regardless of current foul totals.**
7. Only 1 free throw will be taken for each trip to the line
 - a. 1 free throw taken on foul with made bucket
 - b. 1 free throw taken for 2 points when fouled in the bonus
 - c. 1 free throw taken for 2 points on 2-point shooting foul
 - d. 1 free throw taken for 3 points on 3-point shooting foul
8. Timeouts: 2 full timeouts per game
9. Overtime: Jumpball to begin **sudden death**. FT on all defensive fouls.
10. Each team member must have the same color uniform
11. Players/Coaches are responsible for their own valuables/equipment
